
PLEASE HELP !

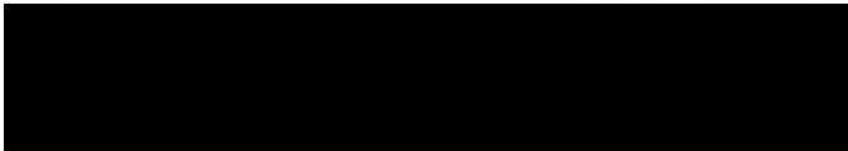
Dear Madam President,

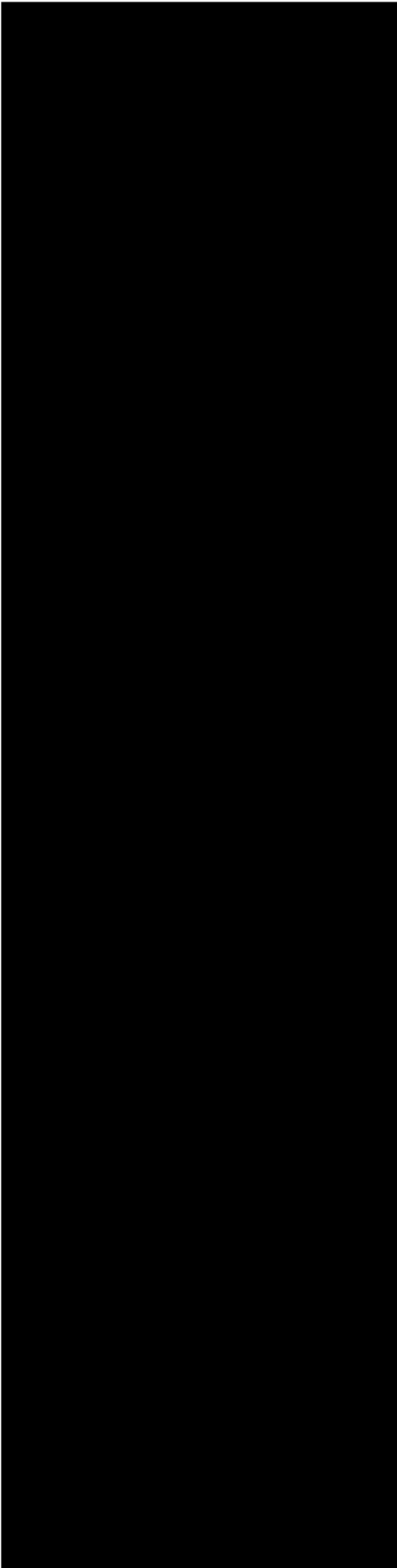

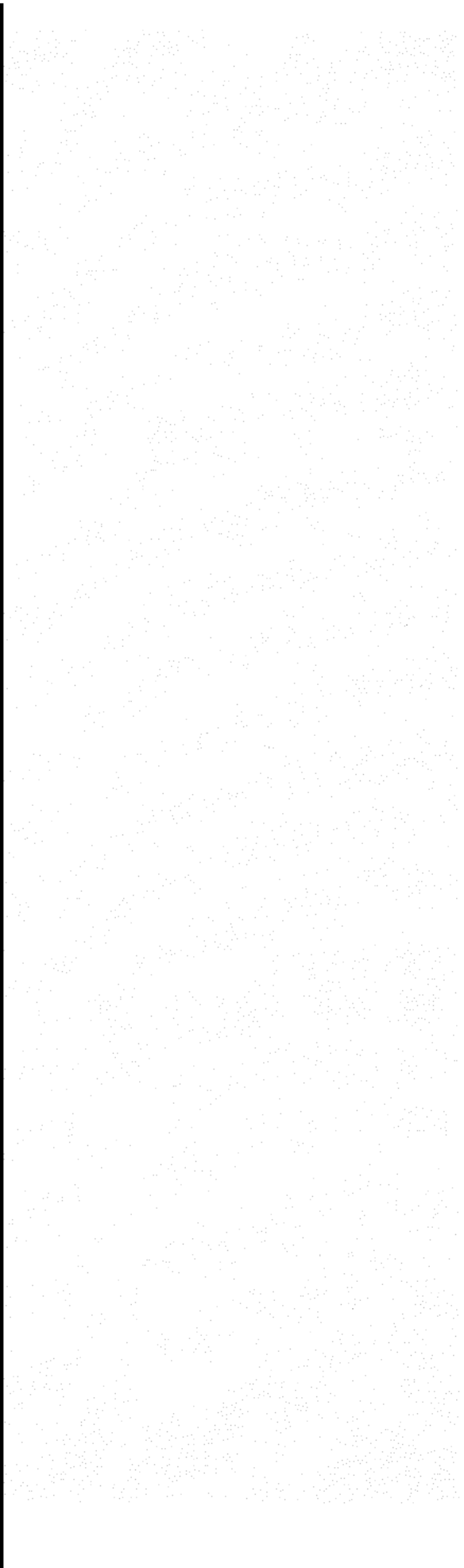

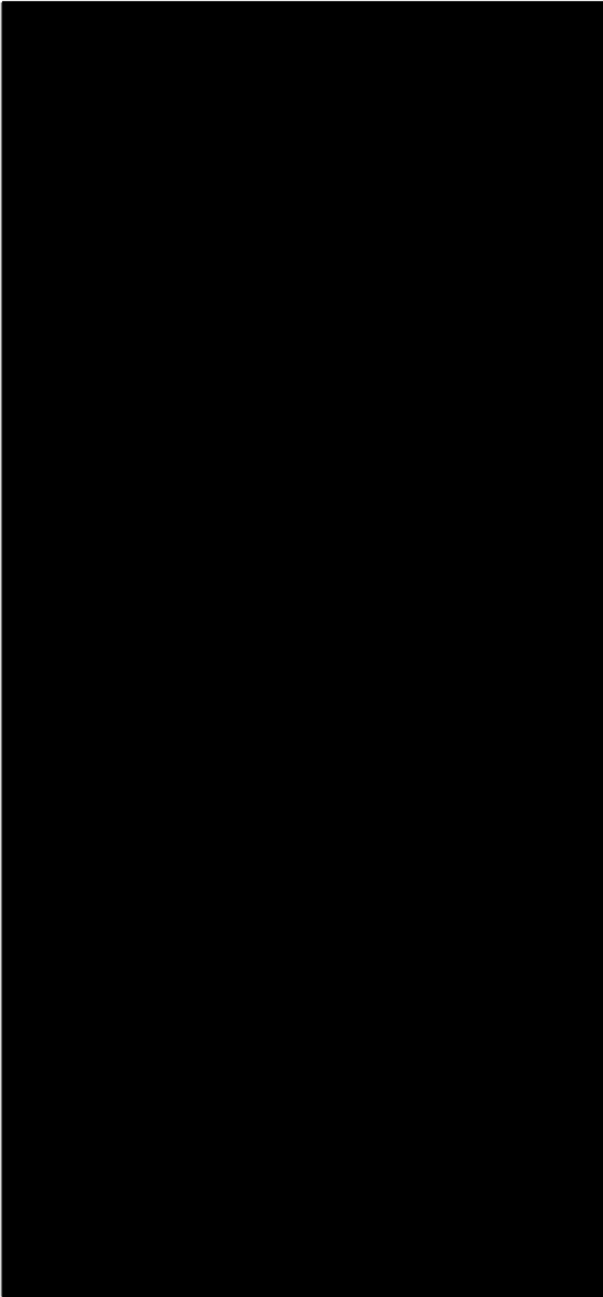
